PUBLIC HEARINGS

1. **RESOLUTION 19D-31:** RESOLUTION AUTHORIZING CONVEYANCE OF OLD RAILROAD PROPERTY IN LINCOLN PARK TO THE STATE OF MINNESOTA FOR \$179,500

Mr. Fulton identified the half-moon shaped parcel located behind the DTA bus garage. This property was acquired by DEDA as part of the Soo Line Railroad acquisition. MNDOT approached the City and DEDA about the acquisition as part of the Twin Ports Interchange project. The fair market value of this property is \$179,500.

2. **RESOLUTION 19D-33:** RESOLUTION AUTHORIZING AGREEMENT TO ACQUIRE CERTAIN TAX FORFEIT PROPERTY FROM THE STATE OF MINNESOTA THROUGH ST. LOUIS COUNTY AND TO CONVEY IT TO SMDC MEDICAL CENTER FOR THE REGIONAL EXCHANGE DISTRICT PROJECT

5. **RESOLUTION 19D-33:** RESOLUTION AUTHORIZING AGREEMENT TO ACQUIRE CERTAIN TAX FORFEIT PROPERTY FROM THE STATE OF MINNESOTA THROUGH ST. LOUIS COUNTY AND TO CONVEY IT TO SMDC MEDICAL CENTER FOR THE REGIONAL EXCHANGE DISTRICT PROJECT

Staff: No additional comments.

6. **RESOLUTION 19D-34:** RESOLUTION APPROVING THE DEDA 2020 BUDGETS

Staff: Mr. Fulton explained this budget does not reflect the sale of property to MNDOT, which will be a positive revenue to DEDA. Mr. Fulton reviewed the different funds and anticipated expenditures and revenue. The MRO Fund 866 does anticipate additional repairs to the roof.

Discussion: Commissioner Aronson Norr asked if the MRO fund is reflective of the commitment to workforce development and recruitment. Mr. Fulton answered that yes, the fund shows the \$50,000 allocation.

Vote to Approve Resolution 19D-34: Passed Unanimously. Russ/Filipovich (5-0)

7. **RESOLUTION 19D-35:** RESOLUTION AUTHORIZING A CONTRACT FOR ASBESTOS ABATEMENT FROM THE PASTORET TERRACE AND ROBESON BALLROOM BUILDINGS WITH ACCT INCORPORATED IN AN AMOUNT NOT TO EXCEED \$65,600

Staff: Mr. Fulton explained this resolution is regarding the potential next steps in asbestos abatement. This abatement work will not affect the pending litigation or building outcome. This work is necessary whether the building is rehabilitated or demolished.

Discussion: Commissioner Filipovich asked if asbestos abatement is worked out in a development agreement. Mr. Fulton answered that asbestos abatement can sometimes be part of a development agreement and sometimes is a matter of course. Mr. Filipovich asked if this work had been thought about before the RFP was put out about a year and a half ago. Mr. Fulton said he was not aware of any such conversations. Commissioner Aronson Norr asked if the City would wait out the 30 days. Mr. Fulton explained the abatement of asbestos needs to happen whether the building is rehabilitated or demolished.

Vote to Approve Resolution 19D-35: Passed Unanimously. Filipovich/Russ (5-0)

DIRECTOR'S REPORT

Mr. Fulton asked the DEDA Commissioners to take the survey for the upcoming brownbag meeting to discuss the Entrepreneur Fund and Monaco Air's proposal. We continue to make progress on the skywalk system extension.
